State Required Course Work:

The Georgia Real Estate Appraisers Board (GREAB) rules and regulations require individuals to complete the AQB recommended coursework for each level as they elevate. Additional courses are required for each level of advancement. Individuals DO NOT have to repeat courses for each level but should complete the new required course (indicated in yellow) for the desired designation level.

*Equivalent Education - College Course Work:

If candidate does not have a full degree, the following may satisfy requirement:

CR Level: Successful completion of college-level courses for three semester hours or five quarter hours each in English composition, economics, finance, higher mathematics, statistics, basic computer applications, and business or real estate law.

CG Level: Successful completion of college-level courses for three semester hours or five quarter hours each in English composition, micro and macro economics, finance, higher mathematics, statistics, basic computer applications, business or real estate law, and two courses in accounting, geography, economics, business management, or real estate.

State Licensing Rules
